

The AAMC strongly believes that the various costs associated with applying to medical school should not be a barrier.

The <u>AAMC Fee Assistance Program</u> assists premeds who, without financial assistance, would be unable to take the MCAT, apply to medical schools that use AMCAS, and more.





Due to the many challenges facing premeds during the ongoing pandemic, the AAMC adjusted the income eligibility criteria.

 Applicants to the 2021 Fee Assistance Program will be granted benefits if each household reported on their application has a 2020 total family income that is 400 percent or less than the 2020 national poverty level for that family size (previously set at 300 percent or less).


There is a reconsideration process for applicants experiencing financial loss of income due to coronavirus.

 If an applicant is denied 2021 Fee Assistance Program benefits based on 2020 household incomes, they can submit a reconsideration request. To request reconsideration, applicants should email <u>fapreconsideration@aamc.org</u> or call 202-828-0600 to be provided with the Reconsideration Request form.


Application and Acceptance Protocols for Applicants

Accepted Applicants and Plan to Enroll Breakdown @






Figure 2. Main menu.





Alternative Grading & AMCAS

The <u>Guidance on Grading and</u> <u>Transcript Notations in the</u> <u>AMCAS Application</u> assists advisors and applicants with understanding the potential impact of alternative grading policies on applicants' cumulative and BCPM (Biology, Chemistry, Physics, and Math) GPAs.

Guidance on Grading and Transcript Notations in the AMCAS Applicatio

The disruption of school terms because of the coronavirus (COVID-19) has compelled many academic institutions to implement alternative grading polices. The AMCAS Advisory Committee has encouraged schools to take these changes into consideration when reviewing applications this cycle and screening for applicants. AMCAS is communicating with schools, pre-health advisors, and applicants to assist with understanding the potential impact of alternative grading policies on applicants' cumulative and BCPM (Biology, Chemistry, Physics, and Math) GPAs.

Using the <u>AMCAS Application Grade Conversion Guide</u>, an applicant can estimate their cumulative and AMCAS GPAs. Applicants are also encouraged to use the <u>MSAR Advisor Reports</u> and reference schoolspecific grading requirements for the most current information. For more information on how to enter coursework and grades, please see our <u>AMCAS Applicant Guide</u>.

Grading and the AMCAS GPA

In the AMCAS application, all courses with credit hours and letter grades **are** calculated into the AMCAS GPA, regardless of whether the credit is counted towards a degree or has been counted towards a school-calculated GPA.

Binary non-qualitative grades (e.g., pass/fail, credit/no credit, and satisfactory/unsatisfactory) do not have value or weight on the AMCAS GPA. These classes are counted in Supplemental Hours in the application *unless* a school provides an alpha letter grade conversion. Applicants should review their school-specific grading policy to understand how alternative grades are reported. Courses graded on a pass/fail basis are usually indicated by special transcript grades and/or symbols designating pass and fail.

How are grades reflected in the AMCAS GPA?

Experiences

- The Work/Activities section in AMCAS will remain as is for the 2022 application cycle
- Medical schools are encouraged to ask via secondaries about the nature of the experience, why it was meaningful, and how it impacted the applicant's journey to medicine
- Some schools may also ask how the pandemic affected applicants

i	The Work and Activities section is designed to give you the opportunity to include in your application any work or extracurricular activities that you would like to bring to the attention of the medical schools to which you are applying. You can add up to 15 entries. You will be prompted to summarize each experience. As part of this process, you will be asked to identify up to three experiences that you consider the most meaningful. If you have two or more entries you will be required to identify at least one as the most meaningful. When considering which experiences are the most meaningful, you might consider the transformative nature of the experience: the impact you made while engaging in the activity and the personal growth you experienced as a result of your participation.

Using the Choose Your Medical School Tool

Important Considerations for Applicants

- Protecting applicant privacy and choice is one of the core tenets of this tool.
- Use of the tool is determined by each medical school to which you apply.
 Please be familiar with each school's processes and procedures.
- Ensure that you follow each school's guidelines if you wish to withdraw your application from a school after you have made your final decision.
- If you have questions about school-specific policies regarding the tool, you should communicate with the school directly.
- Become familiar with the Application and Acceptance Protocols for Applicants, which are the guiding principles for professional behavior during the medical school application process. These guidelines are not intended to supersede the policies, timelines, or discretion of individual schools or programs. However, they do provide a sense of professionalism that the medical schools are looking for from applicants.






Applicant Options in AMCAS Application

Plan to Enroll

Wording Prior to April 30:

Plan to Enroll: I have preliminarily selected this medical school as the one I plan to attend in accordance with Protocol 9 of the Application and Acceptance Protocols for Applicants. Medical schools can only see aggregate information until April 30th and will not know which applicants have selected "Plan to Enroll" at their school or at other schools. Beginning April 30th, medical schools can see which of their accepted applicants have selected "Plan to Enroll" at their institution. I understand that I can continue to interview, hold my current acceptance offers and receive additional acceptance offers, and remain on any waitlist at any other medical schools to which I applied.

I acknowledge and understand the Choose Your Medical School option I have selected above, my responsibilities of direct communication with the medical schools, and the importance of following school-specific application policies and processes. I understand that information about my selection will be made available as noted at the top of the page.

By selecting "Commit to Enroll," I am indicating that I have made my final selection and withdrawn all other applications, including waitlist positions.

I understand that it is my responsibility to communicate my withdrawal and acceptance decisions with medical schools directly and to follow their school-specific processes to withdraw my application(s) or confirm my acceptance. Selecting "Commit to Enroll" is not an appropriate method of withdrawing applications from other medical school(s), including any which have offered me an acceptance. Beginning April 30th, medical schools can see which applicants have selected "Commit to Enroll" at their institution.

Choose Your Medical School Tool Applicant Options — A Summary

- Option available February 19

 - Note: beginning April 30, the only difference is that applicants should not be holding multiple acceptances in accordance with the Protocols.

Commit to Enroll

- Option available beginning April 30
- Summary of Option:
 - Applicant is indicating they have made a final selection and withdrawn all other applications, including waitlist positions.

February 19-April 29

Medical schools can only see <u>aggregate data</u> about applicant selections

April 30 – End of Cycle

Beginning April 30, medical schools can see **<u>detailed</u>**, **identifiable** information about application selections.

Note: medical schools will not see information about which other medical school an applicant selects and whether any particular applicant has any other acceptances.



Choose Your Medical School Emails

Emails to Applicants (beginning Feb. 19)

- 1. Confirmation email each time they make a selection.
- 2. Notice of selection being removed due to a change in admission action by selected medical school.

Emails to Schools (beginning April 30)

- 1. Notice of applicant selecting Commit to Enroll to another medical school. Note: name of other school not disclosed.
 - i. Only for applicants in a non-final action (as reported to AMCAS).
- 2. Notice of applicant changing Commit to Enroll selection. This includes deleting current selection, changing to Plan to Enroll, or selecting another school.
