Effective calendar year 2022, the AAMC has modified two of its eligibility requirements for the Fee Assistance Program:

- Removed the U.S. citizenship and certain visa status eligibility requirements and instead will require a U.S. address.
- Removed the requirement for parental financial information for applicants age 26 and over on the day the application is submitted.



2023 Application Dates

Application Deadlines

- Application must be submitted by 11:59 p.m. ET of the deadline date
- Transcripts must be received by AMCAS within 14 calendar days* of the application deadline date (or the next business day if the deadline date falls on a weekend or holiday)
- *For Early Decision Program applicants all transcripts must be received by Monday, August 1

Important Reminders

1. Follow school-specific policies and procedures: Review each school's application instructions, policies, deadlines, and requirements. We recommend visiting each school's admissions website, checking Medical School Admission Requirements, and directly communicating with the schools where you applied to ensure you understand their specific instructions and procedures.

2. Review the AMCAS Choose Your Medical School tool information: Many schools use the AMCAS Choose Your Medical School tool. On Tuesday, February 22, 2022, this tool becomes available within the AMCAS application to *applicants who receive an acceptance offer from a participating school.* You should use the tool at the direction of the school(s) to which you applied.

3. Understand Professionalism Expectations: The Application and Acceptance Protocols for Applicants are guiding principles for professional behavior during the application cycle. They are not intended to supersede the policies, timelines, or discretion of individual schools or programs. Expectations of Professionalism During the Medical School Admissions Process and Tips from Admissions on Maintaining Professionalism Throughout Your Interview also highlight areas of professionalism that medical schools are looking for from applicants.



Important Dates Overview

Important Reminder: Several key admissions process dates fall on a weekend or holiday this cycle; therefore, their availability shifts to the next business day.

Tuesday, February 22, 2022

• *"Plan to Enroll"* becomes available for accepted applicants to select in the Choose Your Medical School tool, located within the AMCAS application (note: only applicants who receive an acceptance offer from a participating school will be able to see and use the tool)

Monday, May 2, 2022

- "Commit to Enroll" becomes available for accepted applicants to select, in addition to "Plan to Enroll," in the Choose Your Medical School tool, located within the AMCAS application (note: selecting "Commit to Enroll" does not automatically withdraw applicants from other medical schools).
- Per the <u>Application and Acceptance Protocols for Applicants</u>, applicants should narrow their acceptance offers to one, with no limit on the number of alternate list offers they may hold.

Common Questions and Scenarios



Common Scenarios

- School is requiring an applicant to accept a merit-based scholarship by selecting "Commit to Enroll" (CTE) on or around May 2
- 2. School is asking an applicant to select CTE more than 4 weeks prior to matriculation
- 3. Schools offering acceptances to applicants who 1) already matriculated, or 2) in CTE at another school
- 4. Schools not reporting a withdrawal that applicant already communicated applicant showing up as holding other acceptances when they already withdrew



Final Reminders



Important Reminders

- Applicants are encouraged to:
 - Review <u>Choose Your Medical School</u> information; the tool is not the primary means of communication between the applicant and the medical school
 - Follow school-specific policies and procedures for using the tool
 - Professionalism on the part of all stakeholders is critical for the tool's success
 - Become familiar with the <u>Application and Acceptance Protocols for Applicants</u>, the guiding principles for professional behavior during the medical school application process
