2025 Testing Year

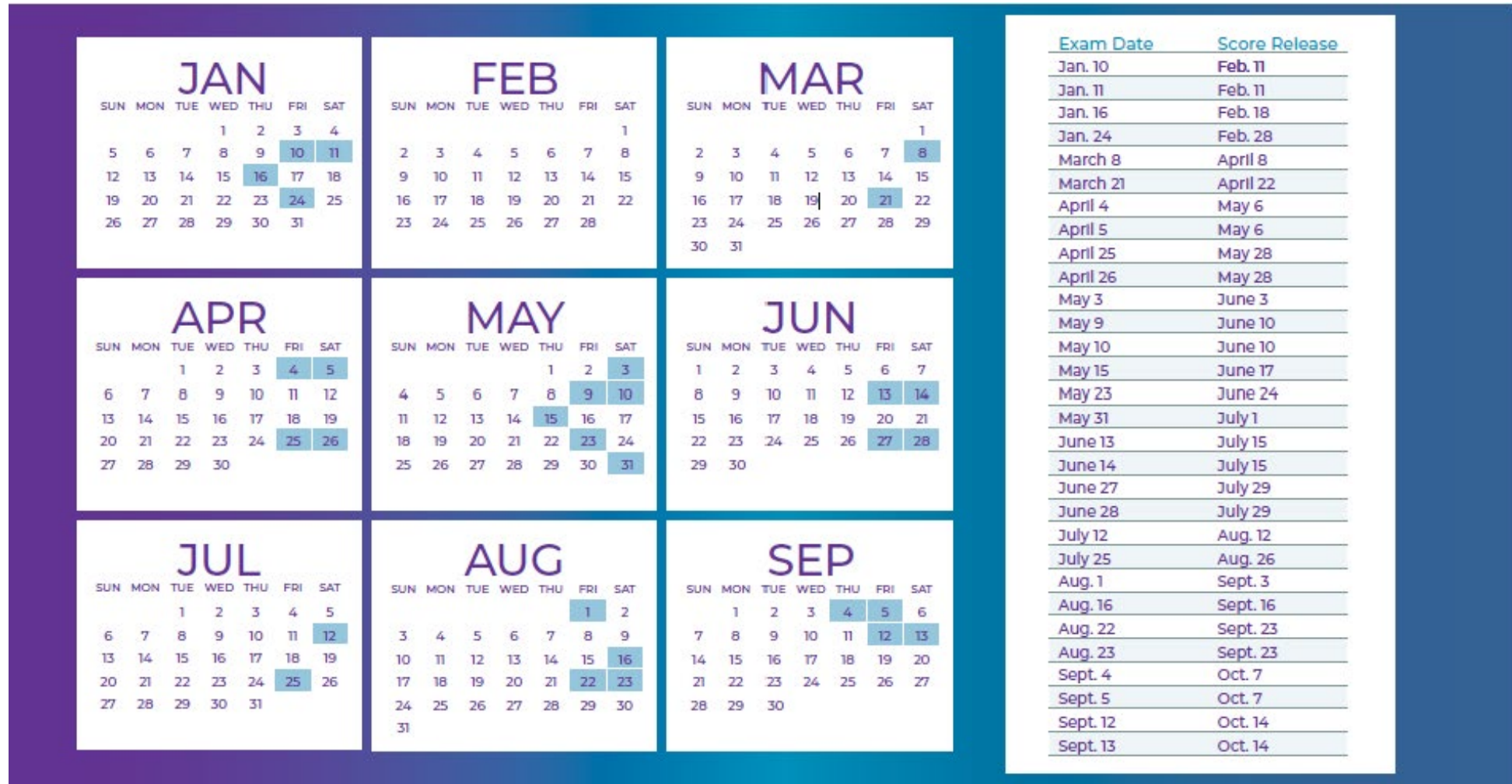
2025 MCAT Testing Year

January – September

- 30 exam dates
- One administration per day (8:00 a.m.)
- 30-35 day score reporting

AAMC Fee Assistance Program

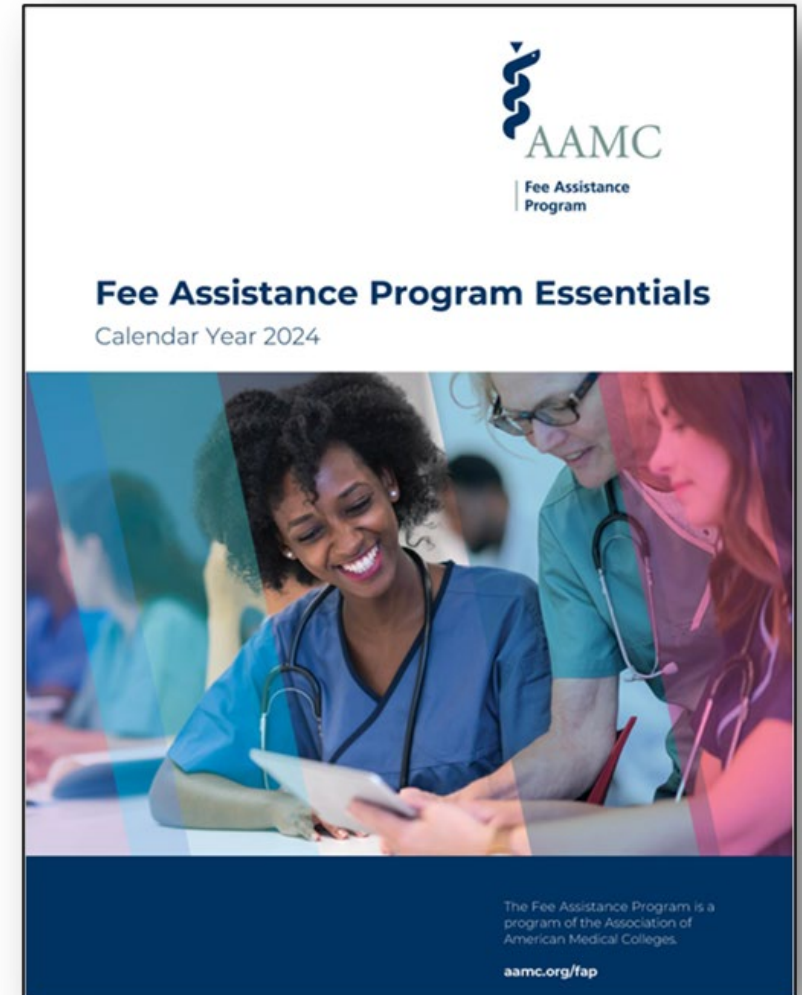
The AAMC's Fee Assistance Program helps those with financial need. It defrays the cost of preparing for and taking the MCAT exam and applying to medical school.

Deadlines: Application is open now. Apply 5 days in advance of when you plan to use the benefits.

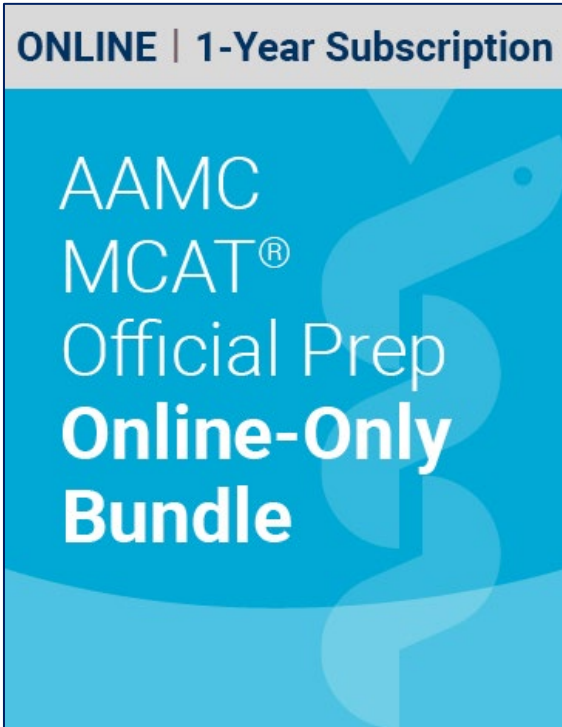
Eligibility

- Open to everyone with a U.S.-based address.
- Approval tied to U.S. Department of Health and Human Services' poverty level guidelines. Awardees are granted fee assistance if each household reported on your application has a total family income that is 400 percent or less than the national poverty level for that family size.

Parental information not required for students over age 26.

Testing with Accommodations

The AAMC is committed to providing all individuals with an opportunity to demonstrate their proficiency on the MCAT exam, including ensuring access to persons with disabilities.

- **Nearly 2%** of examinees test with accommodations
- Examples of **disabilities or conditions** that may result in the need for accommodations include:
 - Chronic medical condition (e.g., diabetes)
 - Vision impairment
 - Learning disability
- Commonly provided **accommodations** include:
 - Extra testing or break time
 - Medical devices and/or supplies in the testing room
 - Separate testing rooms

Suggested First Steps

- **Start early:** allows time to understand the process, collect documentation, await application review, and schedule exam with accommodations
- **Review the website,** in particular:
 - Introduction video
 - Information on standard testing conditions
 - Recommended submission dates (based on preferred exam date)
 - Understand the application requirements and evaluation guidelines
- **Where to apply: MCAT Accommodations online application system**
 - Applications and documentation submitted online for secure and efficient processing
 - Access decision letters
 - Submit accommodations-related service requests
 - Beginning on Oct. 10, the process of applying for MCAT and PREview accommodations will be integrated into one system

MCAT Registration

Registration Dates: 2025 Testing Year



October 2, 2024
January and March – June test dates

February 2025
July- September test dates

2025 Fall Registration

September 18 - Students can begin filling out profile information in the MCAT Registration System.

- Contact and background information; review terms
- Look up locations of test centers
- Prescheduling for students testing with accommodations
- System closes at **11:00 a.m. ET on October 1**



October 2, 11 a.m. (ET) – Registration Opens!

"Notify Me" Feature



Get notified by email if a seat becomes available.

- Available appointments are on a first-come, first-notified basis.
- Examinees can have up to **5** active notifications.

What is an MCAT-Accepted ID?



To ensure your ID meets MCAT requirements, please review the MCAT-accepted ID guidelines below.

MCAT Registration

- The names on your ID must match the first and last names on your MCAT exam registration EXACTLY. (Middle names or initials are not required on the MCAT registration, even if they appear on your ID.)
- Enter your name as your first name and then your last name (surname), even if your ID lists your last name before your first name. If they don't match exactly, you must update your name through the MCAT Registration System at least 10 days before your exam.
- If your ID has your initials in place of your first and/or last name, or if your initials are on the same line as your first or last name, you must contact AAMC Services (202-828-0600) for instructions at least 30 days before your exam.

IDENTIFICATION (ID) REQUIREMENTS

You must meet all the following requirements for your ID to be accepted on test day.

1. The ID was issued by a government agency.
2. The ID's expiration date is *printed* on the ID and is not extended by a sticker or similar mechanism.
3. Your ID must not be expired.
 - » If your ID will expire before your scheduled test date, you are responsible for obtaining an updated ID prior to your exam. Account for the processing time of government agencies when selecting an exam date.
4. The ID contains a photo that can be used to positively identify you.
5. The ID is tangible and whole, with no evidence of tampering (clipped corners, holes, etc.).
6. The ID is in English.

- Name on the ID must exactly match the name you used to register.
- Don't use autofill when registering.

ACCEPTED

The most common forms of ID are:

- ✓ State driver's license (with all above requirements).
- ✓ Passport (with all above requirements).
- ✓ Passport card.
- ✓ Permanent resident card (green card).
- ✓ Employment Authorization Document.
- ✓ Canada health card (Ontario and British Columbia ONLY).
- ✓ Consular ID card.
- ✓ Canadian aviation card.

NOT ACCEPTED

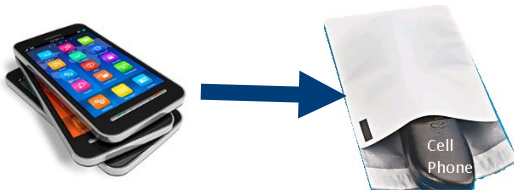
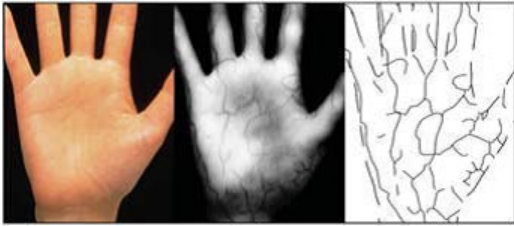
Any single ID that does not fulfill the above requirements, even if issued by a government agency. This includes:

- ✗ Paper ID or ID application receipt of any kind.
- ✗ Credit card.
- ✗ Veterans ID (VIC).
- ✗ Birth certificate.
- ✗ Social security card.
- ✗ Virtual or digital ID.
- ✗ IDs with extension stickers or renewal paperwork, or ID application receipt of any kind, as we are unable to validate authenticity.
 - » Exception: Military personnel and dependents stationed outside their home state may present a state-issued driver's license with extension stickers or paperwork that meets all other MCAT-accepted ID conditions **along with their unexpired Uniformed Services ID card.**
- ✗ School ID.
- ✗ Employee ID.
 - » Even if issued by a government agency, it will not be accepted.
- ✗ Library card (including those issued by government agencies).
 - » Cannot be validated.

- Examinees whose IDs do not meet requirements will need to request an ID Exception no less than 3 days before.
- Paper renewals and/or receipts will not be accepted for admission without an approved ID Exception.

Examinee Agreement



Why it's important?

- Protects integrity of the Exam
- Ensures MCAT scores are reliable and valid, and ensures a fair registration process



Examples of previous violations?

- Using unauthorized materials (notes or devices)
- Proxy testing
- Posting test content online

What can happen?

- Canceled scores
- Report sent to schools
- Registration privileges suspended
