In addition, we consider the path the applicants have taken, which led to their desire to apply to medical school and become a physician.

The availability of late afternoon and evening classes means that potential applicants can complete the required in person prerequisites for medical school without having to resign from their jobs, thereby broadening access to medical education for a more diverse range of applicants.




