Interview: We use the Multiple Mini Interview (MMI) to delve more deeply into the applicant's experiences and gain a deeper understanding of attributes relevant to a medical career. Our MMI is a blinded (closed-file) interview process. 4. Candidates selected for interviews will be notified by e-mail. At this stage, only those candidates who have been interviewed can be considered for admission.</p> <p>Decisions for admissions are made on a rolling basis. Acceptances will continue until the class is full. Admission is provisional until candidates complete all required program requirements. Admission decisions are final and thus are not subject to appeal. A student not admitted as a result of the first application may file a second application the following year, however a third application cycle is strongly discouraged. Applicants for the upcoming application cycle can count on our commitment to the following principles:</p> <p>Pass/Fail Grades – The UCR SOM will accept pass/fail grades, without prejudice, for courses taken during the COVID-19 pandemic. It has always been our practice to consider grades in the context of numerous other aspects of the application, and an international crisis certainly provides a unique and compelling context. In making this statement, we are cognizant of the fact that some undergraduate schools are providing an option for students to take courses either for grades or on a Pass/Fail basis. We therefore want to be explicit that applicants should not feel pressured by us to choose the graded option.</p> <p>Online Coursework– The faculty of the UCR SOM require that students demonstrate a strong foundation that indicates preparedness to engage the curriculum. Our preparation areas are required, however we recognize that there is an increasing degree of variety in premedical course tracks and course offerings at colleges and universities. We further recognize that students may meet these competencies through alternative means or courses, including online. On our secondary application we invite applicants to explain and describe how they have met the requirements through course work and/or additional means. The committee will NOT systematically disqualify candidates due to variation in course completion. The committee will holistically evaluate the preparation of candidates for the school of medicine with a strong focus on science foundation and professional competencies.</p>

Applicants that do not satisfy one of these three eligibility requirements will not be considered.</p> <p>---</p> <p>COURSEWORK RECOMMENDATIONS</p> <p>It is recommended that students enter medical school after four years of undergraduate study; the absolute minimum requirement is attendance for three academic years at an accredited college of arts and sciences, with at least one full year at an accredited 4-year institution in the United States. Students who have attended a foreign school must have completed at least one year of study at a four-year college in the United States prior to applying. FL	Florida State University College of Medicine	<p>All applicants must receive a bachelor's degree by the time of matriculation. Admission to the Florida State University College of Medicine (FSU COM) is a highly competitive process with approximately 6,500 applications reviewed to select the students admitted. A number of academic and personal factors are considered by the Admissions Office and the Admissions Committee when admitting students to medical school.</p> <p>The FSU College of Medicine employs a holistic, mission-aligned approach during the admissions process. Regarding admission to the regular M.D. program, we evaluate all of the following: course "load" and undergraduate rigor; graduate course work; service and volunteer record; shadowing and knowledge of the medical field; research activities; likelihood of practicing within the State of Florida; undergraduate grade point average; MCAT score; and degree of "fit" with respect to our unique mission statement.</p> <p>While a truly holistic approach to admissions makes it difficult to establish minimum academic standards, the Florida State University College of Medicine does not – except in special circumstances – consider applicants for admissions to the regular M.D. program who do not have an MCAT score of at least 500, and an undergraduate grade point average of 3.5. Special circumstances include students who come from medically, financially, or educationally disadvantaged backgrounds. Finally, the Florida State University College of Medicine does not – except under rare circumstances – consider applicants who are not legal residents of the State of Florida, unless such applicants can demonstrate significant ties to Florida. Please look at our website FAQs for examples of significant ties.</p> <p>If an applicant is currently enrolled in a degree program, the program must be completed and transcripts provided to the FSU COM Admissions Office prior to the beginning of classes, unless an exception is granted by that program.</p> <p>The Admissions Committee at the FSU COM is comprised of approximately 60 members and includes faculty from all FSU COM departments, fourth year medical students, and community physicians.</p> <p>When considering applicants for admission, the Committee utilizes all appropriate information including academic, personal, experiential, and geographic data in the selection process. Personal qualities such as motivation, sensitivity to the needs of others, excellent oral communication skills, and maturity receive particular attention along with strong academic credentials. In addition, personal attributes such as compassion and altruism that are, in the view of the committee, essential to the art of good medical practice are of special interest in the selection process.</p> <p>The Committee is especially interested in applicants who have demonstrated through their lifestyle, consistent motivation for service to others.</p>
