Suggested Practices for Programs

- Inform applicants about your program requirements, interview process, timelines for sending
 and conducting interviews, and interview cancellation policy by publishing this information in
 the "Program Information for Applicants" section in <u>ERAS Account Maintenance (EAM)</u> or
 including a link to your website.
- Limit the invitations offered to the number of interview slots available and provide applicants with a reasonable deadline to respond (a minimum of 48 hours is recommended) before offering additional interview invitations.
- If you are not inviting an applicant for interview, inform them of their status with your program (e.g., wait-listed, not invited for interview, etc.). If your program uses a waitlist, communicate the process used for filling interview slots that become available.



Suggested Practices for Applicants

- Work with your advisor(s) to craft an interview strategy that supports your priorities.
- Determine the maximum number of interviews you can reasonably attend and prioritize them by program.
- Practice professional courtesy by providing a timely response to all interview invitations and
 cancellations as early as possible. Scheduling an excessive number of interview time slots that
 you cannot possibly attend could result in a bad representation of your institution, limit other
 applicants' opportunities, and is inconsiderate of the interviewers' time.
- Plan your interviews in advance by trialing your ability to have the setting and technology to participate in your interviews optimally.
